X **Target Date** for CalUsource spend data publication and Procurement Dashboard refresh

Occurs when campus spend files are submitted on-time, no data anomalies observed, and no additional data validation is required during the initial review.

X **Latest Date** for CalUsource spend data publication and Procurement Dashboard refresh

Occurs when extra time is needed to address data anomalies and perform additional data validation and correction. This delay could be further extended if the campus spend file delivery is impacted by the campus accounting month-end close or data shifting.

X **Benefit Bank Approval Deadline**
Benefits must be submitted and approved by this date.

Reminder:

Campuses are required to submit the previous month's spend data by the 8th business day after the month-end closure. The submitted campus spend data will undergo classification, normalization, and validation before being published in CalUsource and refreshing the Procurement Dashboard in the following month.
